2020 POOL SEASON AND COVID 19 ALERT INFORMATION

Due to the continued presence of the COVID 19 virus in our society, the Box Hill North Board of Directors will be following enhanced safety and health protocols for our pool members and our staff's protection for the 2020 pool season. We are happy to be able to make the pool available to our homeowners and residents during these trying times. ***Membership types and prices are being reduced for this year. IF AT ALL POSSIBLE, the board is trying to extend the pool season for our patrons following Labor Day to include the September weekends (Friday, Sat. & Sun.) if staffing is available.*** Please understand that this year's pool season will be different from previous seasons because of the COVID 19 virus. Maryland state officials have mandated that the allowable pool capacity be drastically reduced. In keeping with additional state mandated safety protocols, the board has to make the following changes to pool procedures, and pool rules which may supersede some items printed in our standard pool packets.

- No one should come to the pool if they are not feeling well, running a temperature or showing signs of COVID 19 virus.
 - Instructions and pool rules will be clearly posted on signs & bulletin boards at the gate and within the pool complex area.
 - Frequent hand-washing is encouraged.
 - Hand sanitizer will be available for use in very limited quantities due to manufacturing issues and high demand.
 - Masks must be worn when entering, sunbathing, or leaving the pool complex (including pool deck/grassy areas/bath house).
 - No masks are to be worn while inside the pool itself.
 - Children under two are not required to wear a mask per safety protocols
 - Six feet of separation is required in between pool patrons and pool staff at all times (whether in the pool or out of the water)
 - Maintain six feet of separation from other pool patrons/staff while waiting in line to enter the pool.
 - Family groups must keep six feet of separation in between their group and other pool patrons and staff
 - Until further notice, the state mandated allowable capacity is 160 people permitted at the pool at one time
 - Pool staff will strictly enforce allowable capacity, and they will maintain a log of each person entering
 - Each person must wait at the entry desk area until the staff has logged you (and anyone in your family) in.
 - Once patrons leave the gated area, they will not be allowed to immediately return if other patrons are waiting to enter
 - Once capacity is reached, the pool staff will admit additional patrons at the gate only when other patrons leave
 - There will be no special July 4th celebration event this year.
 - No pool parties, no gatherings, no concession sales, no daycare memberships, no pool pavilion access
 - At this time, no guests are allowed due to capacity restrictions (could change in the future)
 - No baby pool will be available to use (currently state mandated; could change in the future)
 - No babies and/or toddlers allowed in the main pool. No swim diapers in the main pool.
 - Children 3 and over may use the main pool as long as they are toilet trained
 - Patrons will only be permitted the use of a pool inner tube, noodle, or raft – no pool toys or balls.
 - No sharing of rafts, noodles, inner tubes, toys or food with other patrons or friends unless you are within a family group
 - Patrons should plan to bring their own folding chairs and/or folding tables. You may also bring a canopy or beach umbrella to be used in the grassy areas only. Due to sanitation protocols, we cannot supply them!
 - Food will be permitted (delivery and/or bring your own – no glass containers or bottles are permitted)

Please note that exposure to the COVID 19 virus can occur anywhere there are a group of people gathered and especially while out in public areas. COVID 19 is a disease that is very contagious. This virus can lead to extreme sickness and associated complications leading to death in some cases. The Centers for Disease Control and Prevention (CDC) advises extreme caution for high risk groups of people such as seniors over 60 years old and in people with certain health conditions concerning exposure to the virus while visiting public places.

By reading this notice and signing the attached B.H.C.S.A., Inc. **“2020 Pool Season -- Risk / Liability Agreement”** you indicate that you thoroughly understand the dangers and risks of contracting the COVID 19 virus while visiting and swimming at the Box Hill North community pool and its surrounding public areas including pool deck, grassy areas, restrooms, showers, and changing areas. The Box Hill North Community Services Association, Inc. and its Board of Directors, staff and managers will not be held responsible or liable for any patron's exposure to COVID 19 contracted while visiting and using the pool and surrounding areas in the complex. In choosing to join the Box Hill North community pool, you acknowledge that you will be assuming any and all risks of being exposed to and/or contracting the COVID 19 virus. The Board of Directors of the B.H.C.S.A., Inc. reserves the right to modify, restrict and/or close the pool, if the need arises, and if the state issues another public health emergency directive that we must comply with. ****YOU MUST SIGN AND RETURN THE ATTACHED RISK/LIABILITY AGREEMENT AND RETURN WITH YOUR SIGNED POOL REGISTRATION APPLICATION.****
